**NOTICE**  
**B.TECH. (SECOND, THIRD YEAR AND FINAL YEAR BRANCHES)**  
**ACADEMIC YEAR 2026-27**

Eligible students of the above classes are required to pay their tuition & other fees for the Academic year 2026-27 **from 13<sup>th</sup> July, 2026 to 25<sup>th</sup> July, 2026** through the options given below:

1. **ONLINE** payment through Login portal via link provided in the mail.

For the payment of the regular academic fees, students are requested to click on the "**Fees Status Tab**" on the student portal. Two payment gateways will appear as below:

**1. PAYU & 2. HDFC Payment Gateway**

Students, paying their fees online via payment gateway are required to login in using their respective user ids through the link provided in the mail.

The SAP id of the students is his/her respective user id for the portal. The initial Password is set as **init@123**, which has to be changed, when one logs in for the first time. After the login is done, the payment tab will be displayed. On clicking the payment tab, the student will be taken to the payment gateway and via this, he/she can pay the fees through net banking with their bank account details.

Students have to enter their email id on the payu /HDFC payment page to get the transaction alerts. Student will then receive status confirmation on their email id, which is entered by them. In case a student enters the wrong email id, he/she will not get the status alerts.

Fee receipt will be generated and issued by e-mail once the payment is cleared and credited to the college account and this will be done within 4 working days after the payment via PAYU/HDFC Payment gateway.

2. **Demand Draft / Banker's Cheque** drawn in favour of Dwarkadas J. Sanghvi College of Engineering, payable at Mumbai.

The details of fees for all categories, subject to changes, if any, by the concerned authority are displayed separately on the College website and Notice Board. All students of B.Tech. (All Branches), whose term for F.E. (Semester II) and S.E. (Semester IV) and (Semester VI) is granted for admission into B.Tech. (Semester III and V and VII) and are required to pay the fees latest by **25<sup>th</sup> July, 2026**.

**Please note that:**

1. The facility for online payment of fees will be made available only upto the last date, as mentioned in the notice.
2. Non-payment of fees by due date, can adversely affect the attendance records and or may lead to disciplinary action.
3. Students belonging to various categories (EBC/OBC/ST/SC/SBC/VJNT/SEBC) may note that it is their responsibility to comply with the formalities connected with the Government Authority guidelines.
4. Students who wish to apply for educational loan, may note that its their responsibility to get the formalities completed on or before the due date for payment of fees.
