### Admission to First Year B.Tech. Programs (A.Y. 2025-26) Against (CAP [Open], CAP [GCLM] & Institutional Level) Vacancy Seats

Applications are invited from eligible candidates for admission to **First Year B.Tech.** programs against Vacancy seats under CAP [Open], CAP [GCLM] and Institutional Level Seats. Online applications can be made from **25/08/2025** onwards by using the link available on the college website.

**Note:-** Candidates, who wish to be considered specifically under the GCLM (Minority) category will have to compulsorily make a fresh application in that category along with the application for Open category, failing to do so, they will not be eligible to get Gujarathi category seats. Such candidates should also have registered with the CET Cell as a GCLM candidate.

*As per the CET Cell notification dated 23/07/2025, candidates registered on the CET portal for institute level seat, must also apply separately to the institute.*

### Admission to Direct Second Year B.Tech. Programs (A.Y. 2025-26) Against (CAP [Open] & GCLM [Minority]) Vacancy Seats

Applications are invited from eligible candidates for admission to **Direct Second Year B.Tech.** programs in this college **against possible vacancies** in CAP [Open] and GCLM [Minority] categories.

Applications can be made online from **25/08/2025** onwards by using the link available on the college website.

**Note:-** Candidates, who wish to be considered specifically under the GCLM (Minority) category will have to compulsorily make a fresh application in that category along with the application for Open category, failing to do so, they will not be eligible to get Gujarathi category seats. Such candidates should also have registered with the CET Cell as a GCLM candidate.

### Admission to First Year M.Tech. Programs (A.Y. 2025-26) Against (CAP [Open], CAP [GCLM] & Institutional Level) Vacancy Seats

Applications are invited from eligible candidates for admission to **First Year M.Tech.** programs against Vacancy seats under CAP [Open], CAP [GCLM] and Institutional Level Seats. Online applications can be made from **25/08/2025** onwards by using the link available on the college website.

**Note:-** Candidates, who wish to be considered specifically under the GCLM (Minority) category will have to compulsorily make a fresh application in that category along with the application for Open category, failing to do so, they will not be eligible to get Gujarathi category seats. Such candidates should also have registered with the CET Cell as a GCLM candidate.

**Please note:** An application fee of Rs. 1,500/- per application for First Year B.Tech., Direct Second Year and First Year M.Tech. admissions will have to be paid at the time of making the online application. The processing fee, once paid is non-refundable.

Admissions will be made on the basis of inter-se merit of candidates, who have applied to the institute in the prescribed form within the due date and on the basis of rules published in the 'Information Brochure' by the Competent Authority, Maharashtra State for admission to Undergraduate/Post-graduate Technical Courses for the Academic Year 2025-26. Only those candidates are eligible to apply for vacancy and ILS seats, who have mandatorily registered, documents verified and confirmation of application done -by the Competent Authority, Maharashtra State.
