This is regarding Compliance Report submitted by **Shri Vile Parle Kelavani Mandals Dwarkadas J. Sanghvi College of Engineering, Plot No. U-15, Juhu Scheme, Bhaktivedanta Swami Marg, Vile Parle (West), Mumbai-400 056** for the UG Engineering program which was accredited by NBA in Tier-II for academic years 2018-19 to 2020-21 whose validity of accreditation had expired on 30/06/2021. The accreditation of the program had expired on 30/06/2021 was granted accreditation for AY-2021-22 i.e. upto 30/06/2022 on account of present pandemic situation due to Corona Virus.

2. An Expert Team conducted data verification of the program on 16<sup>th</sup> July, 2022. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The Competent Authority in NBA has approved the following accreditation status to the program as given in the table below:

Sanghvi College of Engineering, Plot No. U-15, Juhu Scheme, Bhaktivedanta Swami Marg, Vile Parle (West), Mumbai-400 056** should submit fresh online application under First Cycle SAR Tier-II June, 2015 Document through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.

5. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **Shri Vile Parle Kelavani Mandals Dwarkadas J.
